### Watseka City Council Meeting

# Tuesday, January 23<sup>rd</sup>, 2024

The City Council meeting was called to order by Mayor John Allhands at 6:55pm. Present were Aldermen Barragree, Marcier, Cahoe, Miller, Anderson, Muench, & Alderwoman Rohlfs and DeLahr.

A Motion was made by Anderson, seconded by Rohlfs to Approve the City Council Regular Meeting Minutes of December 19<sup>th</sup>, 2023. Motion passed 8-0.

Public Comment-Angel Crawford from Iroquois Economic Development Association (IEDA) was in attendance. She passed out a handout and went over their 2023 fast facts.

Alderwoman DeLahr shared that the employee gift card amounts went up, along with all the holidays that they get, they are out and about daily so they are getting exercise where the police are confined to their vehicle unless they are apprehending a suspect etc.

A Motion was made by Miller, seconded by Muench Façade Grant for \$5,000 to JR Developments 127 E. Walnut St. Motion passed 8-0.

#### **Miscellaneous Business**

Solar Farm-The mayor shared that there is a Solar farm Developer a mile and ½ west of the city, and the city has a say so in this. This is being put off until City Attorney Cainkar has more information.

Keith from Robinson shared that the lead service postcards were sent out, very little response back so they will be sending out another rounds of postcards for the inventory. This is an EP requirement with no cost to the city. Alderman Anderson shared that he feels a press release

needs to be issued so the citizens know that this is important, and it is not junk-mail. Scott will work with Carla on a press release.

Keith also shared that there will be a Public Hearing February 13<sup>th</sup> this is for the USDA, Keith is unable to attend he will have a prepared statement to be read in his absence.

Keith also reported the cost of the north street water main crossing, \$664,000.00 this is much higher than the regular bid the railroad had structural requirements that had to be done along with the unknown pipe that was found. This project also had to be manned for 24 hours.

The mayor wanted to give some praise to our department heads the rumor is that Watseka is not liked by other towns. There was a shooting in Sheldon that our PD helped capture and they helped on another incident. Fire Dept does a lot of training at their training facility and the mayor had seen the Fire Chief of Ashkum and he had nothing but good things to say about Watseka. Public Works have helped a few other towns with labor and equipment this shows that Watseka is a god neighbor props to all of them.
